The Alliance of Canadian Dietetic Regulatory Bodies (the Alliance) administers the Canadian Dietetic Registration Examination (CDRE) and is seeking volunteers to serve on the Item Writing Committee and the French Exam Validation Committee.

The Alliance is a national group of regulators of the profession of registered dietitians across Canada. In a consistent national approach, Alliance members work together, to support the regulatory mandate of each provincial jurisdiction, which is to protect the public.

Item writers develop multiple-choice questions based on the Exam Blueprint and guidelines for writing multiple-choice items. All item writers are provided with an orientation on developing test questions under the direction of the examination company (Yardstick Assessment Strategies Inc.). This committee meets once each year. Item writers attend a 3-day meeting every spring in Ottawa, Ontario. The Alliance covers travel and accommodation expenses, and there is an honorarium.

Members of the French Exam Validation Committee review and finalize the French version of the exam. Committee members represent provinces with bilingual designation and/or French dietetic education programs, and their current role is associated with French language practice. This committee meets two to three times every year by teleconference. There is an honorarium.

The Alliance ensures diversity on CDRE committees and recruits dietitians with an understanding of entry-to-practice expectations from various geographical areas and practice areas. The Alliance is currently seeking dietitians with community and/or food service management experience in Atlantic Canada. Please consider volunteering.
